

NUCLEAR

EYES ON PILGRIM MARCH 20th

1 End of Public Commentary on Decommissioning. March 4th was the last day for public comments to the NRC on details of Entergy's proposed decommissioning plan (a 60-year plan); and on the proposed license transfer to Holtec (whose plan for rapid decommissioning appears to involve cutting corners—their financial projections don't add up.) The NRC tends to do what it wants after pretending to listen to the public. (They've just extended Seabrook's license— despite its aging infrastructure and cracked containment dome, and despite the great public outcry — until 2050! See Boston Globe March 6, including Ed Markey's damning comments about this extension, in the Boston Globe, March 6th:

4 AGO's Petition. AG Maura Healey and Energy sec'y Matthew Beaton have filed a

lengthy petition to intervene in the review of the proposed sale and license transfer of Pilgrim Nuclear Power Station, citing financial risks raised by the deal and a lack of adequate environmental study before the start of plant decommissioning. - **5 Massive corruption of SNC-Lavalin exposed by the NYT.** Holtec's proposed Canadian partner in decommissioning, SNC-Lavalin, has embroiled Justine Trudeau's government in its scandal. - **6 Final Grade for Pilgrim.** In early March, the NRC delivered its final assessment of Pilgrim's operational status: after four years of operating in Category 4—one step above forced shut-down (the equivalent of a D- grade) and just three months before its shutdown, Pilgrim has been returned to Category A, the *category requiring the very least oversight*. Meanwhile, on March 13, a full-page ad in the form of a 'Letter to the Community' from Brian Sullivan, Site VP at Pilgrim, appeared in the Boston Globe and the Cape Cod Times, praising the hard work of staff that enabled Pilgrim to leap from Category 4 to Category 1 (no details as to how that miracle was accomplished).
- **7 Action at Federal Level.** On March 4, Senators Markey and Warren and Representative Bill Keating sent a joint letter to the NRC requesting answers to six urgent questions about the planned transfer of license. *Their requests were shockingly rebuffed by on March 7 by an underling at the NRC.* The original letter, attached to the NRC response, can be found at: https://adamswebsearch2.nrc.gov/webSearch2/main.jsp?

- **88 Action at the State Level.** A number of bills related to Pilgrim's decommissioning are working their way through the state legislature. We'll be lobbying for them in the state house. *If you are interested in joining the citizen lobbyists, let me know!* In any case, do contact your local representatives to support these bills; and let Vinny DeMacedo (Senate) & Matt Muratore (House) know that you appreciate the bill they're sponsoring. The topic this year was: How a Bill Becomes A Law-The Legislative Process. Lively groups of four students from seven local high schools competed in two rounds of questions about this topic. The first round consisted of seven teams answering a total of 40 questions. Three finalists were chosen and had 15 questions to decide the final winner. Jennifer Harris, Plymouth Library Director served as the moderator. All 7 high schools including Rising Tide, Plymouth South, Sacred Heart, Silver Lake, Duxbury, Carver and Plymouth North fielded very capable teams and it was very close. They were coached by David Clark, Amy Goldberg and Jeremy Hales.
