





ABOUT CANDIDATES NIGHT: The Plymouth Area League of Women Voters is conducting a Candidates Night, Thursday, April 25 at 7PM at Plymouth Town Hall, Great Hall. Candidates for the Board of Selectmen will be participating.

The following individuals are running for two open seats for a three year term on the Board of Selectmen: Alan Costello, Patrick Flaherty, Shelagh Joyce, Kevin Lynch, Frank Mand, and Tony Provenzano.

Lisa B. Reilly and Dennis Sampson are on the ballot, competing for a one year position on the Plymouth Housing Authority. The five-year and three-year seats on the Plymouth Housing Authority are uncontested. Other uncontested races are those for School Committee, Planning Board, Redevelopment Authority and Town Moderator.

The program will be telecast live on PAC TV. Consult local listings for the times of rebroadcasts.

THE BUDGET

The next Fiscal Year starts on July 1, 2019. Following is the proposed budget to be voted on at the ANNUAL MEETING on June 13, 2019. Please review for the details. Here are the highlights.

- We currently have 60 members, which include two 50+ designated Lifetime members,
 1 student member and 6 additional family members.
- We spent more money than we took in this year, which is unusual. Normally we plan on that happening but it doesn't.
- The expenses that drove that included sending a member to the National convention something we always budget but has happened only once before in recent times,
 website expenses as we paid for more than one year of one part of the hosting
 expense and Voter Services for which we have increased the budget for next year, as
 arguably it is our top priority.
- We did take in \$590 of member donations (members adding to their annual dues) and hope that that continues and that you will consider it. Every donation helps, as we owe \$55 of your \$60 dues to State and National.
- Not to worry though we have over \$1000 of cash on hand and \$3,600 in savings.
- Dues are not being raised by State & National.

COMMITTEE REPORTS

NUCLEAR COMMITTEE. EYES ON PILGRIM. APRIL 2019.

- 1) Awaiting NRC decision. Last month, the AGO filed a *petition to intervene* in the proposed license transfer from Entergy to Holtec (see March Bulletin). Duxbury's Pilgrim Watch filed a parallel petition. Both argue that Holtec's finances and their financial guarantees are insufficient for a full, safe decommissioning, and would therefore put the Commonwealth at risk both financially and environmentally. The petitions also claim that Holtec has failed to fulfill the environmental impact study required by NRC and Commonwealth law. They argue that before being granted the transfer, Holtec must guarantee full financial responsibility and must fulfill the required environmental impact studies. Entergy and Holtec have rebutted these petitions. *The NRC will make its decision by May 15th. Stay tuned! Much hangs in the balance.*
- **2) Holtec proposes to buy New York's Indian Point Nuclear Power Plant.** If federal regulators authorize the license transfer, the firm will own six reactors in four states, most being decommissioned simultaneously, adding to doubts about Holtec's fitness for the job. - 3) Nuclear Decommissioning Citizens Advisory Panel (NDCAP) meets every 3rd Wednesday, PCIS Little Theatre, 117 Long Pond Road. In March, the V. P. of Holtec was invited to address the serious concerns of the committee. Instead she stonewalled every question. Sean Mullin, Chair of the NDCAP, voiced the frustration felt by the board members and the public. Holtec was invited to return for the April NDCAP but at the last minute the company declined to send a representative, declaring there was no further information to share. Again, board members and public vented their frustration. Next meeting: May 15th. This council represents all of us. Come listen, learn and speak out. The last 20-30 minutes are given to public commentary. Consider attending! Make your voice heard!
- 4) Action at the Federal Action. Senators Markey & Warren and Representative Bill Keating wrote the NRC posing six urgent questions about the planned transfer of license. deMacedo (S1949) and Muratore (H2904) – Re level of residual radioactivity after license determination, require assessing costs incurred for radiation control; costs of site remediation. O'Conner (S1992) & Cyr (S1948) – assess \$25 million per year for decommissioning starting in 2020.

Cutler (H3492) and Cyr (S1943) – fully fund Commonwealth and municipality off-site radiological response emergency responses until all spent fuel is removed from spent fuel pool and placed in dry casks.

Balser (H1847) – place monitoring stations throughout a 20-mile radius, store KI in towns within 50 miles, distribute KI to residents within 10 miles, nuclear disaster brochure to each household within 50 miles all until spent fuel has been removed from reactor, placed in dry cask storage or moved off-site.

Meschino (H1970) – assess each not less than \$500,000 for first fiscal year, and thereafter "in amounts that, in the aggregate, are equal to the costs incurred in the prior fiscal year by the department's radiation control program in the performance of its duties under this section," to defray costs of DPH radiation control program.
