# How the New Law Will Affect Fall Elections and League Work

Governor Baker signed <u>H.4820</u>, An Act relative to voting options in response to COVID-19, into law Monday, July 6. The League congratulates everyone involved in passing this important measure to assure that our Sept. 1 primary election and Nov. 3 general election are held in a way that increases the safety of voters and poll workers, eases the workload on local election officials, and creates confidence in the conduct of these elections. The final bill passed unanimously in the Senate and by a 157-1 vote in the House. Thanks to all of you who urged your legislators to act on this bill.

We urge League members and local Leagues to take note of the law's provisions below, to take action to inform voters of the changes and how to vote by mail if they wish to do so, and to offer to assist your local election officials in dealing with the expected increase in mailed ballots and the shortage of poll workers.

Here are the major provisions of the law that directly affect voters:

- •An application for a mail ballot will be sent by July 15 to every voter registered by July 1 before the primary election and by Sept. 14 to every voter registered by Sept. 1 before the general election.
- •Applications must be returned to local election officials by <u>four business days</u> before the election. That is a very tight deadline to receive and return a ballot. Encourage voters to apply for ballots early. Voters who apply but do not receive a ballot or who receive a ballot but do not return it can still vote in person.
- •Voters can request which language they would like for their mailed ballot.
- •Election officials must send an acknowledgement notice and application for a mail ballot to any voter who registers or changes their address between July 1 and Aug. 22, and between Sept. 1 and Oct. 24.
- •In-person early voting is Aug. 22-28 before the primary and Oct. 17-30 before the November election and must include some weekend hours.
- •Voter registration deadline is 10 days before the election instead of 20 days, so Aug. 22 for the primary election and Oct. 24 for the general election.
- •Postage-paid return will be provided for applications and mailed ballots.
- •An online portal where a voter can request a mail ballot instead of submitting a paper application

will be created by the Secretary of the Commonwealth by Oct. 1 at the latest.

Here are the major provisions that directly affect local election officials and how elections will be held:

- •Local election officials can process mailed ballots in a central location before Election Day. No results will be tabulated or reported until polls close. Mailed ballots will not have to be delivered to individual precinct polling places.
- •Voters can deposit ballots in secure drop boxes where provided. Ballots can also be returned in person to local election official offices. Encourage your town to provide such a drop box.
- •If polling locations are changed, those changes must be made and the public notified 20 days before the election.
- •For November election, ballots will be counted if mailed on or before Election Day and received by Nov. 6. For the primary election, ballots must be received by Election Day to be counted.
- •Removes some restrictions for poll workers, including political party affiliation, voter status and residence.
- •Allows elimination of checkout table at polls to reduce the number of poll workers needed.
- •Authorizes electronic poll books.
- •Secretary of the Commonwealth will establish regulations with the Department of Public Health to safeguard health of voters and election workers at polls.



The Secretary of the Commonwealth's office has a list of FAQs on voting by mail <a href="here">here</a>, and there's an application for mailed ballots online <a href="here">here</a> to download and return.

The Voter Table will also be operating phone banks to contact residents in areas with historically low voter turnout and urge people to register and vote. They need people to make those calls. #### **CENSUS PROJECT UPDATE - DISAPPOINTING**

The outcome of this effort was not what I had hoped. The amount of work that went into this project was not rewarded by any appreciable jump in the Census completion numbers.

Multiple facets of the Town of Plymouth were very helpful in the promotion but except for one or two interactions with Marshfield and Duxbury, I received no feedback from the other towns and so have no evidence that they used our material. Both State Reps were involved in the get out the message campaign as was Indivisible Plymouth. So thank you to them. The banner, suggested by and half paid for by the Library, is now posted on the gate to the Library.

Thanks to Lyle over 250 flyers were handed out at a recent Food Pantry special event. We have more to distribute and Lyle is handling that task. Thanks to Bobbie Clark for her help in getting us on WATD for the kickoff. And very special thanks to Dave Buckman for his jingle and to the Plymouth Poet Laureate, Stephan Delbos for his original poem. Both helped spice up the Facebook postings.

Here is the increase from May 10 to July 12th - Bourne is the only one with a sizable difference and the one town I never even got the first acceptance from so we can't take credit for that.

#### TAKE ACTION

POLICE REFORM BILLS - Massachusetts policing bill differences remain unresolved as negotiations continue.

House and Senate Leadership have appointed a conference committee to reconcile their respective bills. The conference committee -- Sen. Brownsberger, Sen. Sonia Chang Diaz, Sen. Tarr, Rep. Cronin, Rep. Gonzalez, and Rep. Whelan -- will work on a consensus bill, which will have to be voted on and then sent to the Governor.

Please urge your legislators and Governor Charlie Baker to support the strongest bill possible.

From the SENATE Bill:

- (1) Section 10, which enables victims of police abuse to seek redress in the courts
- (2) Sections 34-40, which require transparency and public decision-making about local police acquisition of military equipment such as tanks, grenade launchers, and armored vehicles
- (3) Section 37, which establishes a Justice Workforce Reinvestment Fund
- (4) Section 49, which prohibits schools from transmitting to law enforcement personal information about students or their family members
- (5) Section 50, which permits school superintendents to determine whether or not police should be assigned to local schools.
- (6) Section 52, which bans racial and other profiling, requires data collection for all stops, frisks, and searches with, analysis, reporting, and accountability if the data demonstrates profiling
- (7) Sections 59-61, which clarify that individuals petitioning for expungement may do so for more than one record and creates a limited, rather than indefinite, lookback period for expungement eligibility.
- (8) Language in Section 55 2(f) that requires police to plan for de-escalation in advance of protests or gatherings

From the HOUSE bill:

- (1) Section 2, which clarifies that law enforcement misconduct records are public records
- (2) Section 25, which restricts government use of facial surveillance
- (3) Section 78, which establishes reasonable safeguards around the use of no-knock warrants
- (4) The definition of "choke hold" in Section 29(List from Progressive MA)
